Harbour Master Report	 The Harbour Master (HM) read out extracts from his Superintendents report No Notice to Mariners. Some Aids to Navigation have been completed with no concerns. 1 Pilotage Puffin to Port Penrhyn return successfully completed. Condition report on the Moorings in hand. Two private moorings have been set at Rowen Bay. No craning in on the 24th March due to high winds. Expected to take place 6th April. Port Marine Safety Code (PMSC)	The HM was very happy with the visit from the MCA (14/03/23) in which we need to reach an agreement with the Pilot and re-evaluate every 5 years. This in addition to having a Pilot Progression Plan and that their recommendations will be discussed in the Committee Meetings. The Chairman highlighted that the Pilots are self-employed and we would need to agree whose liability it is if anything was to go wrong, whilst also reviewing their competence and physical ability. We can await the final wording of the agreement from the MCA.
