Power Vessel Regulations for The Harbour Limits of Caernarfon Harbour Trust (YHCHT)

1. Every Powerboat or Personal Watercraft user that accesses the Harbour Limits of Caernarfon Harbour Trust must register the vessel with YHCHT. (Permanent mooring Holders within YHCHT Harbour limits) excluded from registration system but not Navigational requirements of these regulations.)
2. To obtain registration, a fee shall be paid, and the owner shall confirm valid insurance to a minimum insurance cover of £3 million Third Party.
3. The appropriate registration permits must be displayed in a visible position on the port and starboard side of the vessel above the waterline - other registration numbers will not be accepted. Applicable vessel not displaying the registration permits will not be authorised to launch or Navigate within the Harbour Limits.
4. Access for Powerboats or Personal Watercraft will not be authorised to navigate within the Harbour limits if the owner has not registered with YHCHT, Gwynedd Council or Anglesey Council or if the registration has been withdrawn.
5. Launching fees may be payable at all designated launching areas. This will be at the discretion of the individually operated launching sites.
6. Age Requirements:
 - 6.1 Must be at least 18 years of age to operate a Powerboat or Personal Watercraft.
 - 6.2 Be aged 15 to 17, and possess a R.Y.A. Certificate of Competence for Personal Watercraft, or the RYA Powerboat Level Two Award. The RYA certificate must be available for inspection at all times.
 - 6.3 Be aged 12 to 14, and possess a R.Y.A. Personal Watercraft Certificate of Competence or the RYA Powerboat Level Two Award and operate under direct adult supervision. The definition of "supervision" is such that the adult, as defined in 6.1 above, is present on board the vessel. The RYA certificate must be available for inspection at all times.
 - 6.4 Under 12 yrs. - not permitted to operate a Powerboat or a Personal Watercraft.
7. Speed Restrictions:
 - 7.1 A wakeless speed shall be maintained within 50 metres of another Personal Watercraft, boat, dock, swimmer, skier, angler, fishing equipment, or shoreline.
 - 7.2 all speed restrictions must be complied with in all designated areas. Where there is no prescribed speed limit, mariners are expected to demonstrate respect to other water users
8. Boating under the influence of alcohol, or drugs is illegal.
9. It is an offence to disturb wildlife. Vessels navigating coastal waters shall not disturb dolphins, porpoises, sharks or other wildlife.
10. The requirements and directions of the Harbour Master or his deputies must be adhered to at all times.
11. Navigation of power-driven vessels in a responsible manner and with due regard to good seamanship is a requirement. International Regulations for the Prevention of Collisions at Sea shall be strictly adhered to at all times.
12. The helmsman of the vessel shall ensure that the approved 'Killcord' is secured to the engine and is secured in accordance with the manufacturer's recommendations. No craft should be under way or making way unless the 'Killcord' is properly secured.
13. Water skiing without an independent observer will not be permitted.

THE OWNER / USERS LAUNCHING PERMIT WILL BE WITHDRAWN WITH IMMEDIATE EFFECT IF THE NAVIGATOR OF THE VESSEL FAILS TO COMPLY WITH ANY OF THE ABOVE REGULATIONS.
